## Children's Justice Initiative (CJI) Alcohol and Other Drugs (AOD) Training Plan

### I. INTRODUCTION AND PURPOSE

The following training plan is proposed to support the dissemination and eventual implementation of the following tools that have been developed under the leadership of the CJI-AOD workgroup, with technical assistance from the National Center for Substance Abuse and Child Welfare (NCSACW). A phased approach is recommended for rolling out the training, and is described below. The fundamental purpose of this plan is to provide the framework for cross-systems training that will result in reducing the number of children in out of home placement by applying changing practices/practical tools for families whose use of alcohol and other drugs has placed them in the child welfare system.

### II. APPROACH

### Phase I: Tool Kit Roll Out

- a. Timeframe/Venue CJI Regional Trainings April/May 2006
- b. Purpose Convey importance of Catch the Vision Tool-Kit, outline anticipated applications, and announce expected timeline. Team format will be introduced

### Phase II: One-Day Team Training Conference

- a. Timeframe possibly October or early November, 2006 (location to be determined)
- Purpose Utilize existing CJI teams to develop and enhance collaborative partnerships for the purpose of facilitating regional implementation of recommended practices in state/tribal jurisdictions
- c. **Goal:** Improve outcomes for families with alcohol and other drug problems within the Minnesota Child Welfare and Court systems.
  - Objectives:
    - i. Participants will understand addiction as a brain disease and its affect on the children and families involved in the child protection court system.
    - ii. Participants will have a roadmap specific to their jurisdiction for improving outcomes for children and families with AOD issues within the child protection court system.
    - iii. Participants will understand their role within the CJI team as it implements strategies to improve outcomes for children and families with AOD issues in the child protection court system.
    - iv. Participants will establish collaborative relationships between the courts, child protection, chemical health, and other stakeholders to improve outcomes for children and families with AOD issues in the child protection court system.
    - v. Participants will check-in on homework from regional CJI conferences.

### Phase III Training for Specific Practitioners

- a. Timeframe 2007, 2008
- b. Target Audiences CJI Teams and service providers including CH and CW.
- c. Purpose Train select audiences on selected practices that are relevant to their area of work
